- 1. Review the most recent congregation profile (a two-year requirement)
- 2. Have the reviewed document approved at the March 2024 Congregation meeting. 2026 Start the Joint Need Assessment process (2 years)

Joint Needs Assessment Committee: a pan congregation committee representing the major components of the church to work under the guidance of an appointed representative of the EOORC Pastoral Relations Committee to evaluate current programs, identify what to keep and what to drop; and to recommend the types of new ministry personnel to be engaged. taking the results to a Region led Congregation meeting to seek agreement and initiate a Joint Search Committee.

Joint Search Committee: 5 - 7-member committee to advertise and seek candidates for ministry at BCUC, according to the agreement(s) to by the Congregation.

Note: Based on my 15 years Pastoral Relations experience, since the Pastoral Relationship of the Rev. Kim and the Rev. Lorrie has been so successful, I suggest that a period of at least one year of Interim Ministry (possibly two) will be best to allow the Congregation to "reset" in anticipation of Calling new minister(s) by 2030.
