Discussion (Younger):

The introduction to the story says that Jews thought Samaritans were lazy and stupid, and that women were not as good as men, and many men wouldn't even talk to a woman who wasn't in their own family. But Jesus was a Jewish man, and he talked to the Samaritan woman he met at the well. Why do you think he started a conversation with her? Do you think he was worried that his friends would tease or criticize him for talking to a Samaritan woman? Do you think that Jesus thought it was a good idea to ignore or be mean to a Samaritan woman because she was not Jewish and not a man?

Jesus was talking with the woman about important things like how it is when God's Spirit comes into a person's life. Was he treating her like she was as good as his friends who were men and Jewish? (yes) How did she act after they talked? Did she feel lonely and left out, or happy and excited?

How about today? Do we have groups of people who get left out or treated badly because they are different from us?

7. M&P Report:

BCUC Ministry & Personnel Committee-Report to the Board – March 18, 2020

In early March Lorrie had her final interview as part of the process to become a Diaconal Minister. In regards to Lorrie's upcoming graduation and appointment, David Stafford gave a notice of motion to the Board during the February meeting.

At this time I would like to move that the BCUC Board officially request of the EOOR Region to approve a Provisional Call to Lorrie Lowes, Candidate, as a Diaconal Minister effective May 1, 2020 (the date of her Commissioning) with the following terms: Part time 30 hours per week; minimum salary of \$57,819 (prorated at ¾ time) plus 0% - actual Salary of \$43,364.25 per annum; basic telephone of \$800 per annum; Continuing Education and Learning Amount to be reimbursed to a maximum of \$1081.50; three weeks study leave (21 days) within each Pastoral Year; vacation of a minimum one month (5 Sundays) within each Pastoral Year; participation in the Centralized Payroll Service; pension and group insurance payments as assessed; travel expense reimbursement as logged based on minimum General Council rate (presently \$0.42/km) (Category A, COL4).

March was to be a quiet month as both Rev. Kim and Lorrie were to be away, as was Ellen. I am pleased to report that Ruth stepped in and seamlessly covered Ellen's absence with about two months experience. March, however, has been anything but quiet with the arrival of the COVID-19 pandemic. Fortunately for us Rev. Kim's travel plans were cancelled and she has been a resource even while taking some time off. Rev. Bailey and Abe handled the March 15th service, which will be the last for quite awhile. Ellen came in on Saturday, March 14th to contact the various groups who use BCUC during the week and let them know it is now closed. Both Ruth and Ellen have continued to come in to work at BCUC for two hours each morning. I had a telephone call with Abe, who has several 'creative ideas' – from YouTube to Twitter to music and more – to reach out, engage and stay in touch with our congregation. We are indeed fortunate to have such dedicated and caring staff.

I am pleased to report that Lorrie and Neil arrived safely in Chipembi, where there have been no cases of the corona virus yet. The meetings with the committee have gone well and Lorrie reported that everyone involved is keen to have this partnership go ahead. She is finding a great many ways that we can be involved with the community. Lorrie and Neil have moved closer to the airport in case they have an opportunity to fly home before their Saturday flights.

Monday evening Premier Ford and Health Minister Elliott issued a statement, recommending "the closure of all ... churches and faith settings". This was followed by Tuesday morning's province-wide state of emergency and statements from the Prime Minister's office and the World Health Organization asking people to work from home and practise social isolation in an attempt to control the COVID-19 pandemic.

9. EOOR Council Report

EOOR Council had its Spring Meeting at Glen Cairn UC on Feb 22nd with the alternate possibility of Zoom attendance.

The majority of the meeting time was taken up by necessary motions to complete the new Governance Handbook Terms of Reference for Leadership Teams which had not been completed at the time of the Fall meeting.

Various items of policy also had to be approved to replace those established by the various presbyteries. These had been processed through in order of immediate priority during the year.

Following a presentation from Multifaith Housing Initiative concerning Veterans House, they were the first appeal to be given permission under the new policy to solicit funds from all charges in the region. It was good to know we were already directing our Lenten Appeal to them.

The financial figures were presented which showed that amalgamation had been well budgeted, with a positive balance at the end, although some expenditures had been suspended for the year until the process could be completed. I have a copy of the figures for anyone who would like to see them at a later date.

Obviously there are now questions about the May meeting in Cornwall.
