#### M&P Report to the BCUC Board on September 16, 2020

#### Rev. Kim - Status:

Rev Kim is on sick leave and under her Doctor's care. She has been referred by The Region to Morneau-Shepell, the firm that manages Short-term and Long-term disability for the United Church – this is a standard procedure. The initial leave period was to be two weeks with a return date of September 21, however, M&P has just learned that the leave is extended to mid October, pending a further review. Worship preparation will be continued by Lorrie with assistance for other (to be determined) until Rev. Kim's return.Sunday,

#### Lorrie Lowes, DM

Lorrie has agreed to manage the work of Ministry during Rev. Kim's leave. The priorities will be Worship preparation,

Pastoral Care, and Committees. Two funerals are also being planned, with a time crunch due to travel and COVID 19 restictions - the families want the funerals as soon as possible.

M&P recommends that Lorrie Lowes' hours be increased to full time (40 hours per week) during the period of Rev. Kim's absence. Approximately an additional \$1,132 per month.

## 2021 M&P Budget

Last month M&P informed the Board that the 2021 increase of the M&P Budget will increase by 1.9% according to the United Church minimums. That was incorrect – the increase is 2.2%, and has historically been applied to all staff wages.

## Membership

The M&P Committee currently has only two active members (David Stafford and Rick Morrison). Jennifer Leeder has not been heard from for several weeks and is not responding to inquiries – telephone or email from David or Ellen in the church office. Consequently, M&P needs at least one person to raise its complement to the UCC minimum of three members as required. David has agreed to act as Interim Chair until someone comes forward to fill the vacancy or the 2021 AGM.

# **Commissioning**

Lorrie Lowes will be Commissioned as a Diaconal Minister on Saturday, October 3, 2020, during the Annual Meeting of the Region. The ceremony will be streamed live, it is recommended that the Congregation be advised as soon as the video links are available.

Has the Board considered a Gift to Lorrie on this occasion? At some time in the future, perhaps after COVID, a Covenanting Service will be arranged where such a gift might be presented.

Kim Vidal can return to full-time work, with an annual salary of \$57,018 plus the normal full-time benefits to be arranged through the M&P Committee. Category A, CoL 4. Carried
